Producer's description

The EST, Model E620-722-1, Type A heat detector is a low profile heat detector designed to respond to a rise in temperature and to a rapid temperature rise rate as specified in AS 1603:Part 1 for Type A detectors. The detector will trigger nominally at 72°C.

The detector has a built-in LED that illuminates when the device is in the alarm state. An output is provided for a remote LED.
